**INTERNATIONAL FRESHMAN FINANCIAL AID STATEMENT OF INTENT**

Caltech admits students on the basis of academic and personal strengths and accomplishments without regard to their ability to meet the cost of a Caltech education. In addition, Caltech is committed to meeting the full-demonstrated financial need of admitted students. In the case of international students, however, the total amount of financial aid funds available is limited. This limitation may result in financial need being a factor in the Institute's admissions decisions for international applicants who are neither citizens nor permanent residents of the United States.

To apply for financial assistance, international freshman admission candidates must submit:

- 1) **This form**, *Financial Aid Statement of Intent*, and most recently filed National Income Tax Return, postmarked by the **January 15, 2012** deadline, directly to:

International students whose form is not postmarked by **January 15, 2012**, or who are denied aid for their first year at Caltech, are **not** eligible for aid for any other academic period while they are undergraduates at Caltech. (Citizens of Canada and Mexico may be considered for aid in subsequent years). Those offered assistance for the first year will be eligible to reapply for aid in subsequent years.
